Declaration of Compliance with the Requirements of the REACH Regulation (EC) No. 1907/2006 and the Candidate List of Substances of Very High Concern (SVHC)

TO WHOM IT MAY CONCERN

Through this declaration, **TERMOPLASTICA SGHEDONI S.P.A.** wishes to inform that its products comply with the requirements set forth by Regulation (EC) No. 1907/2006 of the European Parliament and of the Council, known as REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals). This regulation governs the registration, evaluation, authorisation, and restriction of chemical substances in order to ensure a high level of protection for human health and the environment.

1. Compliance with the SVHC Candidate List

In accordance with Article 33 of the REACH Regulation, we declare that:

- The products supplied by **TERMOPLASTICA SGHEDONI S.P.A.** do not contain any substances included in the Candidate List of Substances of Very High Concern (SVHC), as updated on January 21, 2025, in concentrations greater than 0.1% w/w.
- **TERMOPLASTICA SGHEDONI S.P.A.** constantly monitors updates to the Candidate List published by the European Chemicals Agency (ECHA) and promptly updates this declaration in case of changes.

2. Monitoring and Communication

TERMOPLASTICA SGHEDONI S.P.A. is committed to:

- Periodically verifying the compliance of its materials and components with updates to the Candidate List.
- Promptly informing its customers of any changes that may affect product compliance.
- Providing, upon request, information on the presence of SVHCs to end consumers within 45 days, as required by the regulation.

3. Compliance with Restriction Requirements (Annex XVII)

The supplied products also comply with the usage limitations of restricted substances listed in Annex XVII of the REACH Regulation. These restrictions concern hazardous substances such as lead, cadmium, phthalates, and other banned or regulated substances for use in specific applications.

4. SCIP Notification (Substances of Concern In Products)

If a product contains an SVHC in a concentration exceeding 0.1% w/w, **TERMOPLASTICA SGHEDONI S.P.A.** undertakes to notify the ECHA SCIP database, as required by EU Directive 2018/851 on waste.

5. Supply Chain Compliance and Laboratory Testing

To ensure ongoing compliance, TERMOPLASTICA SGHEDONI S.P.A.:

- Requires suppliers to provide certifications and declarations of REACH compliance.
- Carries out, when necessary, laboratory tests on materials and components to verify the absence of SVHCs above the permitted thresholds.

This declaration is supported by laboratory tests performed by an accredited third party (Chimicambiente s.r.l., Company Registration No. 04856580289, Accredia Accreditation No. 0763 L).

TERMOPLASTICA SGHEDONI S.P.A. also declares that, in accordance with Regulation (EU) 2025/40 on packaging and packaging waste, known as the **Product Packaging Waste Regulation (PPWR)**, which came into force on February 11, 2025, the packaging films it produces are designed and manufactured to be recyclable, in compliance with the requirements set out in Article 6 of the aforementioned regulation.
